

### ***Governor's Club Terms and Conditions***

1. Only current property owners at Kiawah Island, Kiawah River Estates or Cassique qualify for Governor's Club Membership. Failure to own Kiawah Island, Kiawah River Estates or Cassique property will result in a rejection of the membership application unless grandfathered.
2. Personalized photo ID Membership cards must be presented at all Club facilities at the time of purchase or check-in. Discounts only apply if the membership card is presented.
3. Dining reservations may include up to six accompanied guests per party. Only charges made to the Governor's Club member account receive any discount. Discount excludes resort special events and catered functions.
4. As a Governor's Club Member, you are entitled to use the Club facilities during the calendar year as defined in the application (January 1 to December 31) in accordance with the Governor's Club Category selected.
5. The immediate family includes the Member's spouse and their unmarried children under the age of twenty-five.
6. Members, their immediate family, and guests are required to abide by the Rules and Regulations of the Club, as amended from time to time.
7. Golf members may schedule tee times fourteen days in advance at all courses. Social and Tennis Members may schedule tee times seven days in advance at all courses. Golf members have unlimited driving range privileges. Social and Tennis members and all guests must pay the driving range fee to use the driving range.
8. Tennis Members may schedule court times fourteen days in advance. Social and Golf Members may schedule court times seven days in advance.
9. All guests must be accompanied. Members are limited to three accompanied guests per tee time or court reservation and six guests per dining party. Additional accompanied guests must pay the resort guest fee.
10. Address changes must be sent in writing, edited on the Governor's Club website or by email to the Governor's Club office to ensure notification of all necessary departments.
11. Members will receive a 15% discount at the point of purchase on food and beverage and merchandise purchases at Kiawah Island Golf Resort shops and restaurants. Only charges made to the Governor's Club member account receive any discount.
12. Members will receive 15% off on accommodations at Kiawah Island Golf Resort villas and The Sanctuary at Kiawah Island Golf Resort. Only charges made to the Governor's Club member account receive any discount. Only charges made to the Governor's Club member account receive any discount.
13. Membership privileges will be activated when the Club office receives completed application and appropriate annual fees and tax.
14. Golf Members may play at the seasonal member guest rate after exceeding the number of rounds included in the membership or may upgrade to the next category by paying the difference in price between the categories. Additional rounds in increments of 10 may be purchased for \$880 plus tax.
15. Limited Tennis Members may choose to convert their membership from Limited to Unlimited at any time during the year at the listed price. Any hours over the limited number may be played at the member guest rate.
16. The Pool-Add on includes only the member's adult children, grandchildren, parents and siblings. Documentation of relationship must be provided upon request by Director. Each person in the Pool Add-on entering the pool must pay daily guest fee. One additional guest may accompany the Pool Add-On family member, guest fees apply.
17. The deadline for enrollment in the Pool-Add on for adult children is March 1.
18. All balances must be paid before a new annual Governor's Club membership is activated.
19. The Governor's Club members acknowledge that the Governor's Club facilities are owned by Kiawah Island Golf Resort and that a Governor's Club membership card is not an investment, it is not-refundable, and does not provide an equity interest in the Kiawah Island Golf Resort or its facility.
20. Memberships are automatically renewed annually. Members will be automatically billed the fee for the same of most similar category level for the subsequent terms membership in November prior to the new term starting. The term length for each new period is a calendar year. Rates and terms are subject to change.
21. Members may opt-out of the auto-renewal or change the membership category of the subsequent year's membership category if notified before the end of the calendar year of their current term.
22. Membership cards may be used solely by the issued cardholder and may not be transferred or used by anyone other than the person who was issued the card.
23. The Governor's Club Members will be responsible for all charges signed for personally. In addition, any unauthorized charges incurred due to a lost or stolen card will be the responsibility of the Member up to the date that written notice is received by the Club office.
24. In the case of a lost or stolen card, there will be a \$25 replacement fee for a new card.
25. All reservations made at club facilities are the responsibility of the member and must be cancelled in advance or a penalty fee will be applied to the member's account.
26. Kiawah Island Golf Resort reserves the right to close or regulate hours of operation and restrict availability at all Kiawah Island Golf Resort facilities at the discretion of the Director.
27. Privileges of a Governor's Club Member will be terminated if the Director determines that a Member is incompatible with, or disagreeable to the Members or staff of the club, or has engaged in conduct, which in the opinion of the Director, is reasonably calculated to endanger the welfare, interest or character of the Club. In addition, any misrepresentation or abuse of the requirements and guidelines of the Club will result in immediate termination.

29. All requested information is necessary to process an application. A valid credit card number is required. Any monthly statement balance will be automatically charged to the credit on file.
30. Kiawah Island Golf Resort reserves the right to suspend charging privileges for any Governor's Club Member with an account balance which is greater than 30 days past due. In addition, a service charge of 18% per annum will be added to any balance more than 30 days past due. Any balance more than 90 days past due may result in the termination of privileges.
31. All membership dues are subject to 5% South Carolina state tax.
32. Governor's Club members, member spouses and any children of members under the age of 25 are not eligible for employment at Kiawah Island Golf Resort. If a member, member's spouse or member's child wishes to accept employment at Kiawah Island Golf Resort, club membership and all membership privileges will be suspended for the period of employment.
